# COVID-19 deaths reach 20 in Smoky Lake area

Another COVID-19 death was reported in the Smoky Lake region last week, bringing the total pandemic deaths in the region to 20.

According to the Government of Alberta website, as of Dec. 3 Smoky Lake County has had 1,682 reported cases of COVID-19. Last week it had 16 new cases reported, of which 13 cases were active. Smoky Lake County had 1,649 recovered cases and has had a total of 20 deaths. It had an active case rate of 155 per 100,000 people last week. For AHS reporting purposes, Smoky Lake County includes the urban municipalities within it and the First Nations and Metis settlements adjacent to it.

were 17 new cases and
25 active cases. Sturgeon had 1,596 recovered cases and has had
a total of 10 deaths.

Thorhild County has had 203 reported cases of COVID-19. Last week it had zero new cases reported and had one active case. It had 201 cases reported recovered and has had one death. Its active case rate last week was 37 per 100,000 people.

Sturgeon is divided into two reporting areas on the government website. Sturgeon County east has had 370 reported cases. Last week it had one new case and one active case. It had 368 cases reported recovered and has had one death. Its active case rate last week was 16 per 100,000 people. Sturgeon east includes Gibbons and Redwater.

Sturgeon County west and the smaller urban centers within it have had a total of 1,261 reported cases. Last week there were 18 new cases and 24 active cases. It had a total of 1,228 recovered cases and has had nine deaths. Its active case rate last week, including Morinville, was 100 per 100,000 people. Sturgeon west includes Legal and Bon Accord.

### Hello to the Residents of Division 6 Sturgeon County,


